Sir,

With reference to NCTE letter No. WPC/2-32/323230/74/2005/4994 dated 27<sup>th</sup> June, 2005 on above subject and an application of AMAR BHARATI Trust, MOTI PAVATHI, TAL: DEHGAM, DIST. GANDHINAGAR-382308 the State Government is pleased to permit the institution to start B.Ed. course affiliated with SNDT Women's University, Mumbai subject to fulfill following terms and conditions.

1. The college will be run on self-finance basis and no financial assistance will be provided by the State Government. The trust must produce an undertaking in original to State Government in this respect immediately.
2. The Trust shall have to obtain the No Objection Certificate from the Gujarat University, Ahmedabad and from the respective University to which the proposed B Ed. College will be affiliated.
3. The admission to the students will be given strictly as per rules and regulations and due approval of NCTE, Bhopal SNDT- Mumbai University and also of the State Government etc.
4. The institution will have to provide qualified staff, physical facilities and other facilities as laid down under NCTE Act, 1993.
5. The institution will have to complete all the facilities including hostel, within three months as per the NCTE norms and report the same to the State Government.
6. The Trust shall have obtain affiliation from respective University before commencement of above college and such certificate should be sent to the State Government.
7. An amount of Rs. 6,00,000 (Rupees six lacs) which has been deposited as a fixed deposit in the Nationalised Bank for six years in the joint name of the President/Managing Trustee of said institute and the Registrar, SNDT, University, Mumbai must be renewed with interest after every maturing of its. (e.g. after the end of every six years).



This is with reference to the proposal of the Amar Bharti Trust, for opening a new College to conduct the new B.Ed. Course, to be affiliated to the SNDT Women's University, Mumbai, for the academic year 2005-06.

In this connection, the Amar Bharti Trust, is hereby informed that, as authorized by the Management Council vide Resolution No.11 of November 30, 2004 and as recommended by the Director, Board of College and University Development and by the Scrutiny Committee appointed for the purpose, the Vice-Chancellor of this University vide Orders dated May 31, 2005 has provisionally granted permission to the Amar Bharti Trust, to open a new college, to conduct the B.Ed. Course, for the academic year 2005-06.

It may be noted that, the above permission so granted is purely provisional and temporary and is subject to submission of the necessary "No Objection Certificate" from the Govt. of Gujarat. On receipt of the necessary "No Objection Certificate" from the said Administration, the Trust will be required to deposit Rs. 6 lakhs in the Fixed Deposit in any Nationalised Bank in an account in the joint names of the Registrar, S.N.D.T Women's University and the President of the said Trust for a period of six years. This deposit will have to be renewed with the accrued interest for further six years at the end of maturity date (i.e. after six years) and the copy of the receipt of the fixed deposit be produced to this University.

It may be noted that, the provisional permission to open a new college is granted for one academic year i.e. 2005-06, on the following terms and conditions:

1. The Trust/Society/Mandal/Samstha shall meet the financial deficits, if any, by making an outright grant to the College from its own funds.
2. The College/Institute shall appoint the teaching staff and Librarian as per the Staffing Pattern for the College and as the qualifications and procedure prescribed by the University and the NCTE/AICTE/INC as the case may be.
3. The College/Institute shall provide sufficient facilities for books, journals, furniture, fixtures and fittings for class room, laboratories, library and staff room.
4. The College/Institute shall constitute the Local Managing Committee / Advisory Committee, as prescribed under Section 85 of the Maharashtra Universities Act, 1994.
5. The College/Institute shall comply with the conditions laid down by the concerned Government with regard to admission of Students belonging to SC/ST/DT-NI and OBC categories, if any.
6. The College/Institute shall comply with the Orders/directives issued by the Vice-Chancellor and other officers of the University in exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances and Regulations, from time to time.
7. The College/Institute shall send to the University, the progress report of the compliance of the above conditions from time to time.
8. The Trust/Society/Mandal/Samstha shall give an undertaking on stamp paper worth Rs.100/- wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994, and also agree to abide by the rules and regulations as may be framed by the University from time to time.



9. On receipt of the "No Objection Certificate" and the recognition of the Statutory apex body i.e. Indian Nursing Council/NCTE/AICTE, the Trust shall be required to apply to the University for grant of first time affiliation to the proposed course.
10. The University reserves the right to grant first time affiliation to the course or otherwise.

It may be further noted that, in the event of non-compliance of the aforesaid terms and conditions by the Trust/Society/Mandal/Samstha, the permission granted provisionally to open a new College, shall be withdrawn/terminated as per procedure laid down for the purpose.

You are requested to note the same and do the needful and send an undertaking on Stamp paper worth Rs.100/- as referred at Sr. No. 8 hereinabove urgently.


